In living up to our standards of transparency and compliance within the community scheme lending environment, BC Funding Solutions engaged with the National Credit Regulator ("the NCR"), to discuss its lending model, and followed this through by registering as a credit provider. The registration number provided by the NCR to BC Funding Solutions is NCRCP 11132.
